

TEAM WORLD

Minnesota-#1. top seeded team after the pre-lims, held off a charging Northern California team to win the TEAM-WORLD 1992 title. Bev Nathe, Phyllis Negaard, Dale Lipovsky, and Lu Cave represented the top team. Minnesota, which also had another entry, has won this tournament a record three times.

Seven teams made the finals; 1 Minnesota-#1, 2 Indiana, 3 Illinois-#2, 3 Missouri-#1, 5 No California, 6 Saskatchewan, and 7 Illinois-#1. Saskatchewan elected to drop out to make airline connections. In effect the finals became a six team ladder with the Illinois-#1 team in the lowest bracket with Northern California. That match, tied at 2-2, was decided on total points. Northern California then became giant killers out pitching the defending champions, Missouri-#1. A productive but unheralded team of Illinois-#2 gave the Northern Californians their third victory. Indiana, a solid favorite, was next to give way to make the final match-up with Minnesota-#1.

Although finishing next best, Northern California came from fifth position all the way to the top bracket. It was about a five-hundred dollar ride. Each game of the final series the Californians increased their ringer percentage to a high of 68.8%. Minnesota more than met the challenge with a final of 73.8%.

CLUB TEAM

Platteville became the first team to win the Club title in successive years. The same four pitchers who first earned the trophy in '91 won 19 of a possible 28 games. John Udelhofen, Morm Mauthe, LaVern Edge, and Mark Mauthe combined to win the title over Goldendale by two wins.

"B" class competition at Telfer Park was tighter among the leading teams. Madison, entering this tournament for the second time nosed out last year's winner, Kenosha, by a mere ½ game. Paul Federer, John Barden, Chet Hermansen, and Jerry Weikeit, all from Dane County, went into the last game against Kenosha up ½ point and held it. The match was a split, 2-2. and the only match wherein Madison lost two games. Note the resulting team averages ; It was close..

16 teams entering the Club Team Tournament were split into two classes. Beloit Horseshoe Club had 24 courts set-up where there had been ice only a few days earlier. The penetrating cold took its toll. Only a few teams produced near their entering averages. Oddly those teams closest were all in the "B" class.

The 24 courts actually would not accomodate all 64 players at the same time. Each round, four teams took a warm-up break, probably in the heated lobby. Because of the added heat, the ladies room was also popular. Hot chocolate and coffee sales outstripped the foamy stuff this day and nobody even mentioned rolling up those canvas sidewalls.

Only two pitchers won all 7 games and five won 6 of the 7 game round robin. Some teams tied on points others tied on percentage. Fortunately in each case there was a decided victor. In this team format ½ point for tie games eliminated final playoffs.

Awards were \$3 cash per game won and \$160 per team to each class winner.

Although 16 teams seems like a top limit to the Club Team tournament, it is apparent with the addition of the "B" class more clubs can be competitive and may choose to enter in the future. To date no entries have been refused. Hopefully there will be a way to accomodate all in coming years.

TEAM WORLD CONTINUED

The games began Thursday at the Telfer Park Arena in weather more suited for ice hockey than horseshoes and the cold did effect some pitchers with sub-par performances. Others ignored it focusing on the competition. Watch for a May date next year.

Cathy Carter of the Iowa-#1 team warmed-up a bit more in each round. By Sunday she was pitching 85%. For a first hand account ask Dale Lipovsky what its like pitching against all ringers! Carter has become the first to pitch a 100% game (40 ringers) in the TEAM-WORLD.

The state of California, we all know, is perched on shaky ground; known for earthquakes. Its the opinion of the TEAM-WORLD community that people from that western state walk around with a little rain cloud over their heads. How else can one explain the turn of events during the awards ceremony at TEAM-WORLD '92?

Tom Roanhouse, tournament director, was on the stage passing out cash awards. In ascending order team captains mounted the platform. Don Peters took it for Illinois-#1. Vicky Winston accepted for Missouri-#1. Larry Knop was congratulated for Illinois-#2. Fans were applauding. It was a happy but dignified ceremony. Mark Seibold jumped up for Indiana's share.

Now it became time for California to mount the stage of honor. Billie Sue Pennington stepped forward and got the shock of her life. The platform collapsed. Howie Voiles, mike in hand, hopped clear. Mouse Beckius went with the flow. Earl Paulson saved the trophy while Roanhouse and Pennington clutched each other trying to remain upright.

Fortunately everyone survived and will live on in infamy. John Secord was video-taping and is expected to market the scene as part of "NHPA HIGHLIGHTS".

Finally we saw the 'passing of the fire'. Missouri, willing but reluctantly, gave up the trophy to the new winners, the ringer gang from Minnesota.

ATTENTION HORSESHOE PITCHERS

In all my years that I have been involved in horseshoes, I've seen leagues start, grow, and even die. I've seen associations dwindle to the point where classes had to be handicapped in order to have a tournament. Nobody enjoys this kind of horseshoe. I feel the reason this happens is due to lack of communication. You hear people talk amongst themselves and usually that's the end of it. When all is said and done, and it's not done their way, they get disappointed and it may even bring them to quit. Nobody wants this.

I have thought about this and tried to come up with a solution. This is it.

First, I would like to see the state broken into sections (maybe five) - Northeast, Central, Southwest, Northwest and Southeast. At a tournament (or tournaments) held in each of these sections, the players would be given a written list of questions that are pending in the state that they could voice their opinion on. These questions would be put together by our officers and league secretaries throughout the state. Also, there could be a place for new questions and comments. This voting process would occur once a year and only once per member.

Second, the findings would be tallied, both by section and by entire state. These findings would be weighed at the State meeting, as if the members were in attendance.

The reason for the separation by sections is that maybe one section wants to do a certain thing one way and other sections another. What's wrong with that? If this is what the majority in that area wants, that's great! Maybe we all can learn from it.

I'm not saying that everyone should have their own rules; that would be wrong. I'm saying that there are many ways of playing this game and that everyone should have a voice in what they prefer. I feel this would make Wisconsin Horseshoe the best it can be for all.

Let our officers and league secretaries know how you feel about this and maybe we can make this come true!

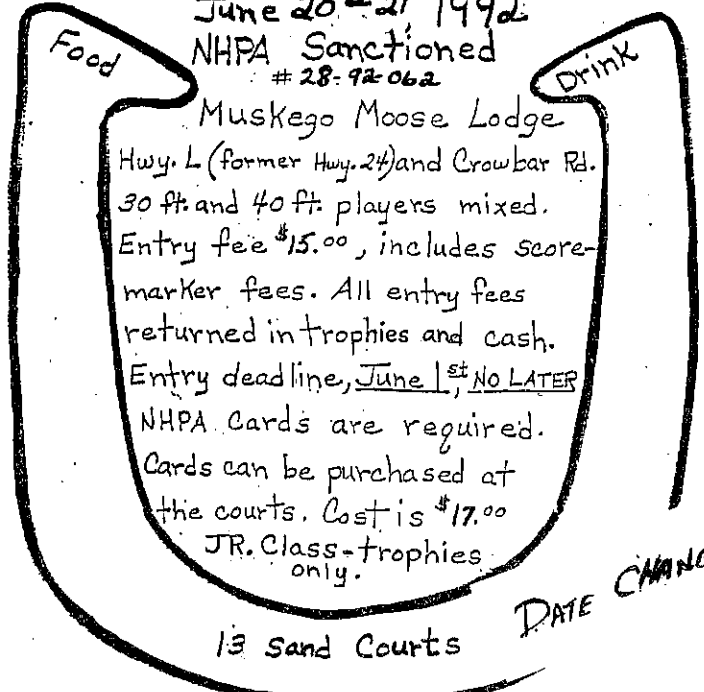

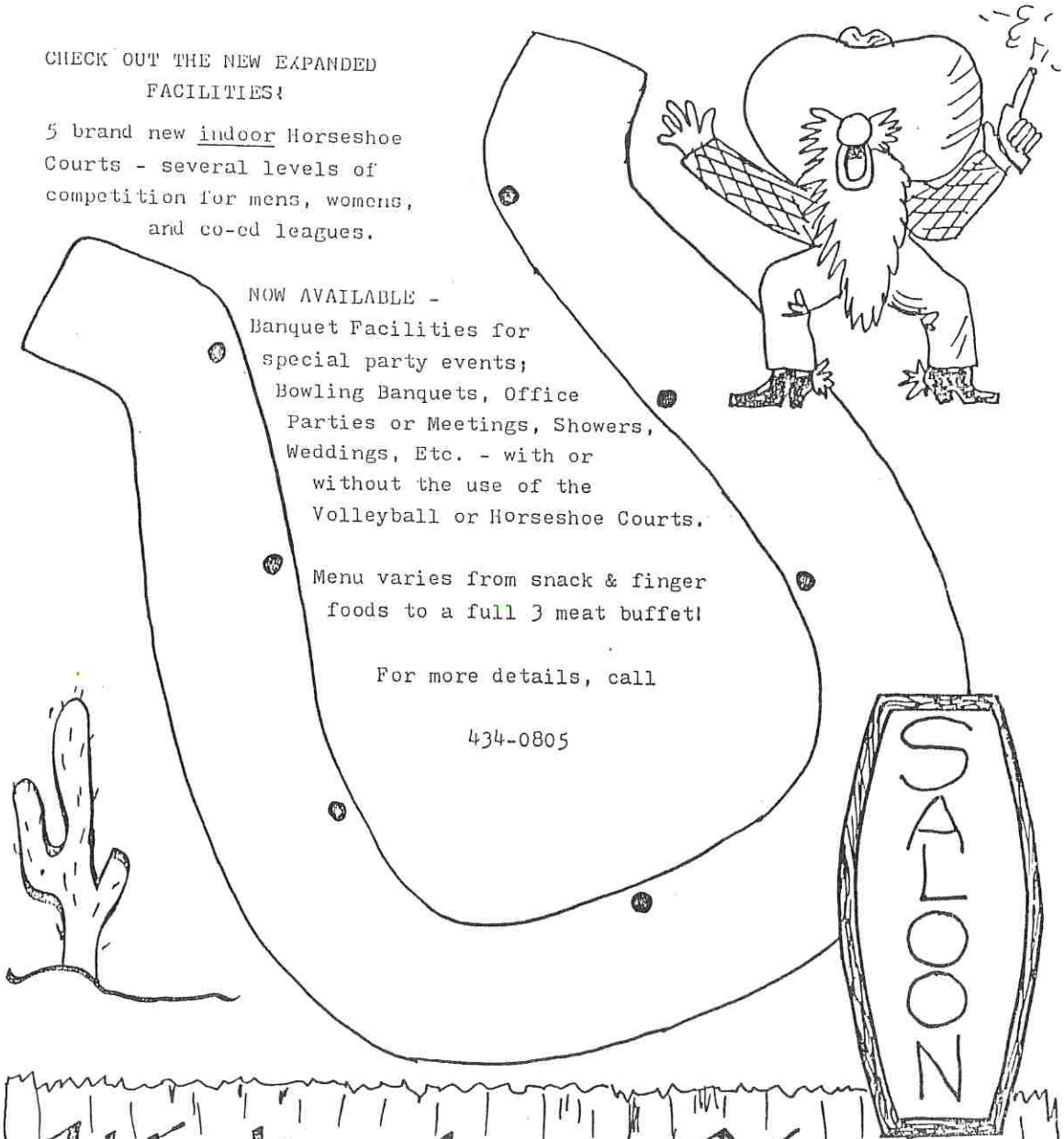
