Border Battle III

The elite pitchers of Wisconsin read their early scores shocked with disbelief. 24 to 8 was the first quarter report. Wisconsin was losing games at the rate of 3 to 1.

The annual Wisconsin - Minnesota horseshoe clash was terminal for the Wisconsin hosts. Minnesota went all the way at the Sandbar winning 80 games to 48 games.

It became a repeat of the previous year with the Minnesotans victory on their home courts in Upsala, MN. The inaugural year, 1999, Wisconsin won on their own courts at Arena. It was thought the event would always belong to the host but the Gopher people anxious to leave their still frozen state, came with bigger guns this year than the Badgers could muster.

The top pitchers of each state are individually invited to this annual pitch-off. Selected, by percentage, are the top eight 30 foot and the top eight 40 foot pitchers. Unfortunately not all of Wisconsin's top pitchers chose to pitch on the BB team this year. Moving down the average list, those pitchers who agree to pitch are further divided into A and B groups of four each. A double round robin ensues in four game shifts. On the eight courts of the Sandbar it becomes a day long event.

Throughout the day there was no doubt of Wisconsin's dubious progress as Ken Kosky entered all score sheets in the unforgiving computer. Even that turned tough. Ringers and points were recorded on the boards

but the computer needed the full score. Up to the task, the scorekeepers marked it both ways, ringer total on the board for the excellent viewing and full score on the sheet for the computer. Eddie Wheeler, scratcher of the day, marked every game.

Other notables in for the day were: for Wisconsin; the VP, Jane Smith, the NHPA Sec-Treas., Dick and Paulette Hansen, and for Minnesota, their NHPA RD, Ward Lutz.



No pitcher went through the day unscathed but the one two punch of the Minnesota 40 ft team, Dale Lipovsky and Gerald Stangland each won 7 of their 8 games. Rosie Lyek, MN 30's, went 7 for 8 and Harry Nelson, WI pitching his personal best tournament also had 7 wins. Nelson and teammate Bun Carley along with Christy Weyer of Minnesota were outstanding, each performing even better than entering average.

Wisconsin team leader, Randy Rein, added comments as he made the award, a new traveling trophy, to Minnesota's team coordinator, Dick Dvorak. Mark Mauthe presented the \$400 purse. Dvorak first thanked Sandbar owner, Dave Forseth, for his

I would like to congratulate Earl Paulson, who never stops promoting the Game of Horseshoes, and Clayton Gage, for his achievements as a pitcher, for their election into the WHPA Hall of Fame. In 1998 the WHPA Hall of Fame committee created an Honorary Hall of Fame, to recognize non-Wisconsin horseshoe participants that have made an impressive impact on the Game of Horseshoes in this state. This year Seneca "Red" Ferguson, who lives in Illinois and is a member of the Beloit club, was elected into this category for his dedication to the Game of Horseshoes. Congratulations Red!

As of April 7- 2001, Dick Hansen informed me that the Chippewa Valley Convention and Visitors Bureau, which is located in Eau Claire was the lone bidder for the 2003 World Tournament. There being no other bidders the 2003 World Tournament will be in Eau Claire, Wisconsin.

The Eau Claire horseshoe club and the WHPA have agreed to support the Chippewa Valley Convention and Visitors Bureau in hosting the 2003 World Tournament. The proposed site is the McPhee Physical Education Center, which is part of the University of Wisconsin, in Eau Claire.

The question that seems to come up a lot is what is the benefit of being an NHPA member. The liability insurance that you get when you are at a Sanctioned Event is one very big reason. Even a claim that is frivolous, for which you may not be at fault can cost tens of thousands of dollars in defense cost. I for one do not want to take that chance and be held liable for the cost of a claim.

For one reason or another the last issue of the Newsletter, a part of the following paragraph was omitted.

I'm willing to award \$100.00 (2001 Presidents fee) to the adult person that signs up the most NHPA members by September 2nd 2001. The person you sign up can not be a 2000 NHPA member. The list must be submitted to me by Labor Day 2001. The submitted name or names can not be duplicated by another person.

Future State Tournaments

Each year at our State Fall meeting, we select a site for our State Tournament two years in advance. This year, we are looking for a club to host the State Tournament for 2003.

To host the State Tournament, you need a minimum of twelve courts and one playoff court with lights and volunteer committees willing to work the tournament. Two or more clubs sharing in hosting the State Tournament has been suggested and actually accomplished in the past few years. Close Doesn't Count Club has doubled up with Eau Claire Club and Windy Hill Club. At this point they are planning on doing the same again next year with the Windy Hill Club at Wausau.

An indoor facility is not a requirement, but can be a plus, eliminates the possible weather conditions that might affect the tournament's schedule, when held outdoors.

At the time of the State spring meeting on March 17, Combined Locks' Bill Matey, was looking into hosting the State Tournament 2003, with some help from the Fox Valley Convention and Visitors Bureau, but at their club meeting, he couldn't get enough commitment from the membership .It's a lot of work, no question about it. The very first NHPA Sanctioned

State Tournament was held at Combined Locks in July 1967. Hopefully they will try again in the near future.

The Goldendale Club's membership was asked if they would be interested in hosting the State Tournament in the near future, at their club meeting. About 75% of the members in attendance, said they would if they could get help from one or two other clubs. The Fond du Lac courts have been offered to Goldendale to use. More information is necessary before the final decision to go ahead.

As a reminder, this year's State Tournament will be held at Beloit, September 1-3 at the Beloit Club's Courts.

So if there are any other clubs out there willing to host or co-host the State Tournament for 2003, please contact me.

WHPA SPRING MEETING AT THE ARENA SANDBAR

Edi McKinney, fresh from the Hall of Fame selection process, announced the 2001 choices with pride. Clayton Gage, champion Elder, will be inducted as a pitcher. Earl Paulson, the push at Beloit, was successfully nominated as promoter, and the angel of the Beloit clubhouse, Red Ferguson of South Beloit, Illinois, will receive his WHPA Hall of Fame plaque as an honorary member.

As usual State Secretary, John Secord led off the WHPA 2001 Spring Meeting with minutes of the last meeting and the treasurer's report showing a balance of \$4,120, up about \$700

over last fall.

Perhaps winter in the Northwest was uninteresting. The ordinarily talkative VP, Jane Smith, declined to comment.

Terry Sternberg outlined the progress with future State Tournament hosts. This year in Beloit the event is expected to go for three full days on the 12 outdoor courts. If, perchance, the club gained a public occupancy permit for the new building, they would be able to complete the event in two days using those indoor courts for all short distance pitchers.

Next year, 2002, plans are still in effect to go to Wausau

with Close Doesn't Count Club as co-host.

Possible bidders for 2003 could be The Combined Locks Club or the Goldendale Club in partnership with unannounced others.

Bill Matey, president of the Combined Locks Club has met with the Fox Cities Convention and Visitors Bureau who seem interested in producing an arena large enough to accommodate courts for a State event.

Goldendale Club is shopping for a co-host and thinking of a Fond du Lac fairgrounds building as a possible site.

Sternberg called attention to the memorabilia section of the Hall of Fame and before the day was out he mounted an additional wall cabinet that he personally made to match the others at the Sandbar.

Tom Steinke reported that the Junior Scholarship Fund now has a cash balance of \$7000.

Lorraine Sternberg, the Sanctioned Club and League Director for the National organization encouraged Wisconsin Clubs to join in and be counted among others on her list of Sanctioned Clubs of the NHPA.

She is also working on a new, 'Red Book,' the primer for the

sanction program.

Junior Promotions Director of the NHPA, Heidi Sternberg, is also the webmaster of the WHPA site. The site has been recently updated with a new look. She asked for any pictures members may wish to contribute and any comments on additional material they would like to see. Heidi has recently produced an outstanding brochure devoted to junior horseshoe pitching, the first of its kind in the NHPA and available to all just for the asking.

Dick Hansen, the Secretary Treasurer of the NHPA complimented Heidi Sternberg for the fine brochure. He then switched to a review of conditions to expect at the 2000 World

Tournament in Hibbing, Minnesota. Accommodations are expected to be tight with only a few left in the town of Hibbing. There will be two pitching arenas located approximately one mile apart. No problems are anticipated because of the dual location. Showers at the facility could be made available but it's no guarantee.

So far the only World Tournament bid for 2003 is from Eau Claire, Wisconsin. It's not from the Eau Claire Club but from the Chippewa Cities Convention and Visitors Association who hope to cooperate with the Eau Claire Club. Last year the Eau Claire indoor site was considered at the convention, but thought to have been unsuccessful for lack of full airconditioning.

Hansen recently mailed 13,000 NHPF brochures, one to every household with an NHPA connection. In an impromptu survey it was disheartening to see that maybe half of the members present could not recall receiving the brochure.

This was first for the NHPF. Finally every member was contacted in the mass mailing of the highly informational brochure. It was also an appeal for funds but certainly not to be discarded as junk mail.

After passing out tournament certificates and NHPA patches, the Regional Director, Jim Haupt talked about treating the "Tournament Champion" patch with respect. He went on, The patch is designed for all "A" class champions but they should be true champions. Try to see that even in a mixed class there is but one champion. Dave Schorbahn advocates issuing double Tournament Champion patches in a mixed Junior class to promote their continued participation. Haupt believes using the Champion patch for trivial reasons reduces its importance and admitted he is not empowered to make a rule but tried to gain general acceptance of a worthy practice.

Finally the meeting got down to business with discussion, originally initiated by Hansen last year, regarding the amount of time consumed pitching the men's championship class. The ten game format seems to some to be too much to watch from beginning to end. Also there was concern for the pitchers. Some changes were offered such as two day competition. The move-up man from "A" would have to double duty on the first day and definitely the "A" move-up would be retained. Although fruitful, the discussion was tabled perhaps for future consideration.

Under new business, the hot topic became scorekeeping at the State Tournament.

Ron Berg, State Tournament Director of 2000, had stated his tournament wrap-up views through a Newsletter article preceding this meeting. One of Berg's points was advocating use of the familiar ringers-points self score for all but the championship rounds which are point games. The argument was that providing scorekeepers is the toughest job for the State host. That and the fact that the ringers-point system has been well received, would seem to be a solution.

Other opinions countered. Terry Sternberg stated that providing scorekeepers is a primary responsibility of State Tournament host and any club should have available scorekeepers in mind before making a bid. Rick Poppe reminisced of the Pitchin' Palace days with scorekeepers clicking those electronic boards. A gang of

people were heard from. This is why the WHPA exists - to govern the State Tournament. Jane Smith suggested that we come back to the question later in form of a rule proposal. Jaeger cited the rule book wherein it is stated that scorekeepers will be paid \$1/game. Jeff Secord assessed the all arguments and suggested that the self scoring question could be handled without rule changes, if, State Tournament bidders would include the choice of that option in their bid. Selective voting members would then have command.

In the course of arguments, pro and con, Jaeger asked for an informal survey of hands for continued use of scorekeepers at the State Tournament. 22 hands were counted while only 13 were in favor of employing the self score option.

Actually the NHPA rules at present call for provision of "scorekeepers for each court" at all sanctioned events. (That includes sanctioned league play) Unless that rule is modified, and it may be at the convention this year, scorekeepers are required at the State Tournament.

Berg thinks if the WHPA were to set State Tournament entries into a computer program upon entry, the director would have an easier time of it expanding the program into class times, round robin cards, etc. As a result he followed through on his promise to give the WHPA the "Walter Ray" program that he used last year. It's the same program used for the World Tournament. Unprepared, President Jaeger, was reluctant to accept the gift considering copyright laws related to computer programs. Berg insisted it was his to give and finally the WHPA accepted, conditionally.

Whether the program is ever employed for the State Tournament is another hot subject.

That was enough for the day. The Spring Meeting adjourned at 2:50 PM

Junior Scholarship Open

Conducted the Day of the Spring Meeting, the Jr Scholarship could not accommodate more than four classes.

It used to be that pitchers dreaded the early morning class time. Now they beg for it. Anything seems better than pitching that late afternoon flight and hit the road in the dark. With a decrease in tournament entries at Arena, the various directors elect to make it one day, three class times. Some guys are saying, hot dog, I got the early class.

At least when we have the meetings at Arena, the courts are the meeting area. At Plover there were always some pitchers foregoing the meeting just to practice.

As it was the tournament pitchers out-numbered members at the meeting.

From the result sheet it looks like the regular "A" pitchers took a day off. Harry Nelson, Kenosha, had a great day but was nicked twice. Linda Johnson, new Kenosha tournament director was heard from taking "B" class with all wins. Rich Wisniewski, Arlington Heights, IL outclassed the competition in "C" with room to spare.

Greg Hehling made a percentage move on Russ Heinritz in winning "D." See the results sheet for casualties and others.

Hall of Fame Inductee from 1982:

Ed Schimek

One of two 1982 Wisconsin Horseshoe Pitchers Association Hall-of-Fame awards is being presented to Edward J. "Eddie" Schimek.

Eddie Schimek started pitching horseshoe in 1925, participating in the state tournament in 1928 for the first time, and for the next forty years, at State Fair Park. He took part in three more state contests at different locations. He won the state championship in 1060, 62, and 63. The "National Horseshoe Pitchers' News Digest" featured his picture on the cover of the November 1963 issue. He won the mideastern at Combined Locks in 1966, and he was City of Milwaukee champion in 1931 and 1948. He was a charter member of the Auer Avenue Horseshoe Club and helped organize the City League. He was president of the club in 1935 and a member for 17 years, and a member of the Washington Park Horseshoe Club for 24 years, winning the Washington Park Class A Championship in 1959.

In 1948, when the World Tournament was held in West Allis, Ed was honored to be asked to practice with Guy Zimmerman. They played three games and Ed won one of them 50 - 37, with 82.6%. He failed to qualify for the World Tournament by 15 points. Guy went on to pitch the first perfect game in a World Tourney and ended up in third place.

Ed also had the pleasure of winning a couple of games from Casey Jones. He appeared twice on WTMJ - TV in 1957 in a show called "Pitching Horseshoes". In 1948 he took part in a Red Cross program At Wood Hospital where he coached the veterans for several weeks, giving them pointers in pitching horseshoes. He also gave out trophies they had at the end of the season.

Since retiring in 1976 as supervisor in the Cost Accounting Department at Johnson Controls, Ed has kept busy playing dartball at Washington Park Senior Center. He is one of the top dartball players in Milwaukee and has received individual awards for highest average, always 500 or better, in the years 1976 through 1981. He bowls in two senior leagues and was on the team that won the championship in 1978, 79, and 80. He compiled the highest average in both leagues, a composite average of 175 the last two years.

Ed was born July 25, 1911 in Milwaukee. He and his wife Katherine, who celebrated their 45th wedding anniversary in June, Have two daughters and six grandchildren.

We congratulate Eddie Schimek and are happy to present this award for his many years of dedication to and participation in the sport of horseshoes.

EAU CLAIRE WORLD 2003

It's in the bag! Deadline for World tournament bids was March 15, 2001. The only bidder is Eau Claire, Wisconsin.

World Convention delegates have only to confirm the bid this summer for the first Eau Claire World since 1987.

At that time the host club was the primary promoter of the event, provided the portable courts, and the necessary labor to setup and maintain the facility. This time the principal promoter is the area convention and visitors bureau and their future participation regarding setup and maintenance is an unknown. It may be that the success of the Eau Claire World will have to depend upon labor participation of state members as a whole.

The 1987 World was the first event of its kind to use portable platform courts. They were at least two years in development, first seen at the 1985 World being shown by Curt Bestul. The NHPA platform courts of today are merely an adaptation of the original Eau Claire courts.

The '87 World opened the door of opportunity for indoor tournaments.

Eddie Wheeler took on the design and production of the unusual result sheets. Bun Carley and Tip Wipperfurth offered advice. Jim Haupt notified the teams. There were a few pitchers who performed well but so few that individual percentages are not published, only team percentages. Anything can happen in doubles play and perhaps that explains low team percentages but the first five were closely matched.

The RVR trophy, a broken concrete block, was engraved on the spot by Tom Endler, a leader of the 2001 Kenosha team.

It has been suggested that the winning team earns the privilege and duty of conducting next years competition for the RVR. Hear, Hear!

TRIBUTE TO THE UNITED STATES

Widespread but only partial news coverage was given recently to a remarkable editorial broadcast from Toronto by Gordon Sinclair, a Canadian television commentator. What follows is the full text of his trenchant remarks as printed in the Congressional Record:
